ORDER

No. 290—Ele. (ML)-16/2008-SEC.—Whereas, it is reported by the Executive Officer, Gunupur N.A.C. that casual vacancy in the office of Vice-Chairperson of Gunupur N.A.C. has occurred due to no confidence motion passed against the Vice-Chairperson on the 20th July 2007;
