No. 6931—Ele. (ML)-98/2008-SEC. —Whereas, State Election Commission vide Order No. 5358, dated the 13th September 2008 postponed the General Election to Phulbani Municipality and G. Udayagiri Notified Area Council (N.A.C.) in the district of Kandhamal, keeping the final list of contesting candidates published on the 8th September 2008 valid, since it was felt that free and fair poll could not be conducted due to the prevailing law and order situation in the district ;

And whereas, this Commission feels that the law and order situation in the district is now conducive to hold the election.

Now, therefore, in exercise of powers conferred by Article 243-ZA of Constitution of India, Section 11-A of Orissa Municipal Act, 1950 and Rule 23 (1) of Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission do hereby appoint the following dates & time for General Election to Phulbani Municipality and G. Udayagiri N. A. C. of Kandhamal district :—
