No. 7487—Ele. (GP)-70/2008-SEC.—Whereas, Collectors, Sub-Collectors of different districts have submitted proposals for by-elections to the Offices of Panchayat Samiti Members, Sarpanches and Ward Members as per Orissa Panchayat Samiti Election Rules, 1991 and Orissa Grama Panchayat Election Rules, 1965 respectively;

Whereas Commission has decided to revise the Electoral Roll for the concerned Panchayat Samiti and Grama Panchayat on the basis of Assembly Electoral Roll published by Election Commission of India during September 2008;

And whereas it is necessary to prepare Wardwise Electoral Rolls for Grama Panchayats as per the list of vacancies appended as Annexure-III for conduct of by-elections.

Now, therefore, the State Election Commission in exercise of powers vested in it by virtue of Article 243-K of the Constitution of India, read with relevant provision of Orissa Grama Panchayat Act, 1964, Orissa Panchayat Samiti Act, 1959 and Rules framed thereunder, directs that Wardwise preliminary Electoral Roll of Grama Panchayats shall be prepared in Form No. 1 as per schedule detailed in Annexure-I according to the procedure prescribed in the Annexure-II of this order. The final Electoral Roll of Grama Panchayat prepared under Orissa Grama Panchayat Election Rules comprised within the Samiti Constituency including revision or addition or alteration if any shall together form the final Electoral Roll of Samiti.

ANNEXURE II

- 1. The Collector as Electoral Registration Officer will be overall charge of preparation and finalisation of Electoral Roll of the concerned Grama Panchayat.
- Ordinarily the Collector may authorize the B.D.O. to function as Electoral Registration Officer in respect of concerned Grama Panchayats as per Rule 2 (d-1) of O.G.P. Rules, 1965. He may also authorise concerned Sub-Collectors and Tahasildar as a stand by measure.
- 3. The Electoral Roll of Assembly Constituency prepared and published by the Election Commission of India during January 2008 and currently in force shall be the basis of preparation of the preliminary Wardwise Electoral Roll. For conduct of by-election to Panchayat Samiti Members Electoral Roll of concerned Panchayat Samiti shall be updated. For the purpose, the Electoral Roll of Assembly Constituency relating to concerned Panchayat Samiti have to be split into separate Electoral Roll for every Grama Panchayat under the Panchayat Samiti Wardwise. Similarly, for the purpose of by-election to Sarpanch the Electoral Roll of Assembly Constituency relating to the concerned Grama Panchayat and for by-election to Ward Member, the Electoral Roll of Assembly Constituency relating to the concerned Wards have to be split into separate Electoral Rolls for every Ward as per Rule 5 (1) of the O. G. P. E. Rules, 1965. The preliminary Electoral Roll shall be prapared in Form No. 1 prescribed by the Commission under the seal and signature of the Electoral Registration Officer.

- 4. The preliminary Electoral Roll of the Ward prepared in accordance with Rule 5(1) of O.G.P.E. Rules shall be published by the E.R.O. at a conspicuous place at the headquarters of the Grama Sasan together with a notice in Form No. 2 in accordance with the provision under Rule 5(3). Such notice shall also be published in the noticeboard of the office of the concerned Panchayat Samiti, Sub-Collector and Collector. It should be ensured that copies of preliminary Electoral Roll is kept open at Grama Panchayat Office for inspection by the public for entire period prescribed during filing of objections or claims.
- 5. Only the claims of persons whose name finds place in the Assembly Electoral Roll but does not find place in the Electoral Roll of the Ward now prepared shall be entertained. No new claims for enrolment shall be entertained.
- 6. After completion of enquire into all claims and objections in the manner prescribed above, the Electoral Registration Officer shall prepare the final Electoral Roll.
- 7. Electoral Roll of concerned Ward and Grama Panchayat and where by-election is proposed as per Annexure-III shall only be printed. Final Electoral Roll and printed copy of the Electoral Roll shall be authenticated by the E.R.O. at every page.
