NOTIFICATION

The 4th December 2008

S.R.O. No.607/2008—WHEREAS, the draft of certain rules, further to amend the Orissa Factories Rules, 1950 was published as required by section 112 of the Factories Act, 1948 (63 of 1948) in extra ordinary issue No. 1247 of the Orissa Gazette, dated the 1st July 2008 bearing SRO No. 328/2008, under the notification of the Government of Orissa in the Labour & Employment Department No.7217-LL-II-FM-22/2008/LE., dated the 1st July, 2008 inviting objections and suggestions from all persons likely to be affected thereby till the expiry of a period of forty-five days from the date of publication of the said notification in the *Orissa Gazette*;

AND, WHEREAS, no objection or suggestion has been received during the stipulated period in respect of the said draft;

NOW, THEREFORE, in exercise of the powers conferred by section 112 of the said Act, the State Government do hereby make the following rules further to amend the Orissa Factories Rules, 1950, namely :-

1. (1) These rules may be called the Orissa Factories (Amendment) Rules, 2008.

(2) They shall come into force on the date of their publication in *the Orissa Gazette*.

2. In the Orissa Factories Rules, 1950 (hereinafter referred to as the said rules), in rule 7, for sub-rule (4), the following sub-rule shall be substituted, namely :—

“(4) the occupier shall have the option to apply for renewal of licence by the Chief Inspector in Form 4A for a term of five consecutive calendar years with five times of usual licence fee in vogue.”

3. In the said rules, after “Form 4”, the following Form shall be inserted, namely : —

“Form 4A”*[See sub-rule (4) of rule 7]***RENEWAL OF LICENCE TO WORK A FACTORY**
