The Government of Orissa in the Labour & Employment Department in exercise of the powers conferred upon them under sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following disputes vide their Order No. 2918(5), dated the 31st March 2006 for adjudication of the following dispute :

SCHEDULE

“Whether the demands of the Union regarding regularisation of services of Shri E. Bhagirathi, Watchman by the Managing Director, SOUTH Co., Berhampur/ Executive Engineer, Berhampur Electrical Division SOUTH Co., Berhampur is legal and/or justified ? If not, to what relief is the workman Shri E. Bhagirathi entitled ?”

AWARD

2. The workman is absent and has failed to provide claim statement as per the mandate given by the State Government. However, for the interest of justice notice has been issued by the Court for filing claim statement by extending further time as stipulated. The notice by Registered Post has been issued as reveals from the postal receipt attached in the record. Presumption can be drawn that it has been properly despatched and received by the workman. Notice issued, dated the 22nd June 2006 is considered to be sufficient. One year seems to have been elapsed in the meantime by granting time. No response is meted out by the workman. No further adjournment will make it fruitful. Hence in the absence of the claim statement it is not expedite, for the interest of justice to pass any award as referred and required by the Government.

Hence ‘No Dispute Award’ is passed accordingly.
