The Government of Orissa in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 have referred the following dispute vide Order No. 7742—1i/1(S)-16/2003-L.E., dated the 2nd September 2004 for adjudication.

“Whether demand of Sambalpur Municipality Mehentar Sangha, Sambalpur for enhancement of Medical allowance from Rs. 500/- to 1,000/- per annum for the Sweeper & Sweeperesses is legal and/or justified ? If so from which date ?”

2. The case is posted today for hearing. Earlier both parties are filed their statement of claims and written statement. Thereafter the Union remained absent before this Tribunal. This shows that the Union has no interest to contest the case. Accordingly No Dispute Award is passed.
