## AWARD

The Government of Orissa in Labour & Employment Department in exercise of their powers conferred under sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947, have referred the following dispute vide Order No. 6483—li/1(SS)-11/2006-L.E., dated the 19th July 2006 for adjudication.

“Whether the management of Rourkela Steel Plant, Rourkela is justified in refusing to pay incentive payment to Shri Jagannath Sahoo as against his promotion Grade of S-5, S-6 and S-7 for the period from the 1st February 1992 to the 31st January 1994, the 1st February 1994 to the 31st January 1996 and the 1st February 1996 to the 12th September 1997 ? If not, what relief Shri Sahoo is entitled to ?”

2. The case is posted today for filing statement of claim by the workman. But today the 2nd party-workman has not filed his statement of claim and files a petition praying to pass No Dispute Award, as he is no more interested to contest the case. Accordingly ‘No Dispute Award’ is passed.
