The Government of Orissa in the Labour & Employment Department in exercise of the powers conferred upon them under sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947), have referred the following disputes vide their Order No. 9831, dated the 17th November 2005 for adjudication of the following dispute :

“Whether the termination of services of Shri M. Suresh, ex-Attender with effect from the 2nd December 2004 by the Management of Jagannath Institute for Technology and Management at Alluri Nagar, P. O. R. Sitapur, Paralakhemundi, Dist. Gajapati is legal and/or justified ? If not, what relief the workman Shri M. Suresh is entitled to ?”

#### AWARD

2. On verification of the order the case record is placed mistakenly in the Circuit Court, Berhampur. The case has not ripened yet to be placed for trial since claim statement has not been filed yet and several opportunities are given to him notwithstanding the mandate given to dispose of the case within six weeks. No fruitful purpose would be served by giving further opportunities. It seems that the workman is no slight interest to press his claim sincerely.

Hence ‘No Dispute Award’ is passed accordingly.
