The Government of Orissa in the Labour & Employment Department in exercise of the power conferred upon them under sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following disputes vide their Order No. 6837(5) dated the 27th July 2006 for adjudication of the following disputes :

“Whether the termination of services of the workman Shri K. Trinath Rao, Ex-Mistry with effect from 20th April 2005 by Shri Abhiram Sahu Employer, M/s. Baba Work shop Near Gummagada, Paralakhemundi, Dist-Gajapati is legal and/or justified ? If not to what relief is the workman entitled to ?”

AWARD

2. The workman is absent. He is absent on repeated calls. No steps taken for complying the Govt's order. The Workman has not filed the Statement of claims though several opportunities are given to him not with standing the mandate given to dispose of the case within six months. Notice has been to the workman by Regd. post. It appears that the service of the notice is held to be sufficient as the postal cover is not received back.

Hence 'No Dispute Award' is passed accordingly.
