ORDER

(MI)-2008-SEC.—Whereas, it has been brought to the notice of State Election Commission that the preliminary Electoral Roll for Keonjhargarh Municipality has not been prepared with due care and caution while splitting it from the relevant Assembly Electoral Roll leading to large omission;

Now, therefore, in exercise of the powers conferred under Article 243-ZA of the Constitution of India and under Section 13 of the Orissa Municipal Act, 1950, the State Election Commission hereby cancels the entire process of preparation of Electoral Roll relating to Keonjhargarh Municipality as per the schedule issued vide Commission's Order No. 737, dated the 29th February 2008 and orders for preparation of Wardwise Electoral Roll afresh in respect of Keonjhargarh Municipality as per the Schedule given below. The procedure prescribed vide Order No. 737, dated the 29th February 2008 will remain in force :-
