## AWARD

The Government of Orissa in the Labour & Employment Department have in exercise of power conferred upon them under Section 12 read with Clause (c) of the sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (for short 'the Act' ) referred the following dispute for adjudication by this Court.

“Whether the retrenchment of Shri Nityananda Pallei, Ex-Peon-*cum*- Watchman w. e. f. 4-1-2006 by the Management of M/s Tarini Wholesale Co-operative Stores Ltd., Keonjhar is legal and /or justified ? If not, what relief the workman is entitled to ?”

2. On notices being sent, the workman did not appear nor filed statement of claim for the reasons best known to him. From this it can safely be inferred that the workman has no dispute with the management or they have settled their dispute outside the Court in the meantime. Accordingly, an award of No Dispute is passed in so far as reference is concerned.
