## AWARD

The Government of Orissa in the Labour and Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 readwith Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 ( 14 of 1947 )have referred the following dispute for adjudication vide their Order No. 5123—li-1(BH-1)- 14/2007 -LE ., dated the 30th April 2008.

“Whether the termination of services of Smt. Sabita Mohanty, Ex- Clerk-*cum*-Typist by the management of Krushna Chandrapur College with effect from 1-7-2001 is legal and /or justified ? If not, what relief Smt.Mohanty is entitledled to ?”

2. In the present reference the workman though filed her claim statement, but did not choose to participate in the hearing despite opportunity. The management inspite of notice neither filed written statement nor appeared on the date of hearing for which it was declared *ex parte* vide Order No. 10, dated 18-3-2009. The conduct of the parties, as aforesaid, leads this Tribunal to draw an inference that the dispute is either no more subsisting or the same has been settled in the meantime between the parties. Hence, in absence of any evidence, it is not possible to answer the reference in any manner and accordingly a No Dispute Award is passed in so far as the present reference is concerned.
