### NOTIFICATION

The 23rd October 2009

No. 5195—FE-II-32/2009-Ex.—After a series of hooch tragedies in the Ganjam district during the months from March to April, 2006, it was felt necessary to bifurcate the Excise District of Ganjam into two Excise Districts, in harmony with the two Police Districts, i.e. Ganjam and Berhampur functioning within the revenue boundary of Ganjam district. The proposal for reorganisation of Excise District of Ganjam into two Excise Districts was under active consideration of Government for sometime past. In order to curb manufacturing, transporting and trading of illicit liquor, to counteract the activities of bootleggers and liquor mafias, and to provide a smooth and convenient administration in the district, Government have been pleased to decide to bifurcate the Excise District of Ganjam into two Excise Districts as indicated in Col. (2) of Schedule below. Each Excise District be kept incharge of a Superintendent of Excise as may be appointed by Government with headquarters as indicated in Col. (3) having jurisdiction to the Range area as indicated in Col. (4) of the Schedule below which covers the charge offices as indicated in Col. (5).
