The S.P.V. will formulate the policy and planning for operationalisation of City Bus Services through contract/outsourcing. The S.P.V. will be incorporated as Joint Venture of the Bhubaneswar Development Authority (B.D.A.), Bhubaneswar Municipal Corporation (B.M.C.), Orissa State Road Transport Corporation (O.S.R.T.C.), Puri-Konark Development Authority (P.K.D.A.) and Puri Municipality. The registered office of the S.P.V. “City Transport Service Limited (C.T.S.L.)” shall be at Bhubaneswar.

The objective/role/charters of the S.P.V. are as under :—

- To provide or secure or promote an efficient, economical, reliable and properly co-ordinated system of city road transport.
- To plan, establish, regulate, monitor the operations of city bus service.
- To achieve a high level operational efficiency.
- To attain financial self-sufficiency.

- (e) To purchase, charter, hire, acquire buses for public transport purpose as also to dispose of any such buses.
- (f) To purchase, construct, sell, develop, take in exchange or on lease, hire or otherwise acquire any assets/estate to develop infrastructure required for efficient operation of the city bus service.

The S.P.V. will have to be registered under the Companies Act of 1956.
