### NOTIFICATION

SUBJECT—Fee Structure for Private Unaided Professional Colleges/Institutions imparting B. Tech. and MBA Course.

No. 18452—I-TTI-45/2008-I.—In exercise of power conferred on Government under sub-section (7) of Section 6 and other provisions of the Orissa Professional Educational Institutions (Regulation of Admission & Fixation of Fee) Act, 2007 and basing on the recommendation of the Fee Structure Committee constituted in terms of interim order of Hon'ble Supreme Court, dated the 1st June 2007 in Special Leave Petition (Civil) Nos. 10318, 10319, 10329 and 10330 of 2007, the Government has been pleased to approve the fee structure of the following colleges with effect from Academic Session, 2008-2009.

(A) Fees Structure for Engineering Programme :
