AWARD

1. This matter arises out of a reference made by the Government of Orissa, Labour & Employment Department U/s 10 & 12 of the Industrial Dispute Act, 1947, in their Memo No. 11206(4), dated the 18th March 2006, for adjudication of the following questions :

“ Whether the stoppage of work (strike) with effect from the 9th August 2004 by the workers of M/s. Keonjhar Agro Minerals and Processing Pvt. Ltd., Jamunalia, Dist. Keonjhar in protest against the retrenchment of two workers is legal and/or justified ? If not, what relief they are entitled to ?”.

2. On notices being sent, the workmen did not appear nor filed their statements of claim for the reasons best known to them. From this, it can safely be inferred that the workmen have no dispute with the management or they have settled their dispute outside the court in the mean time. Accordingly, an Award of No Dispute is passed in so far as reference is concerned.
