AWARD

1. The matter arises out of a reference made by the Government of Orissa, Labour and Employment Department u/s 10 & 12 of the Industrial Dispute Act, 1947, in their Memo No. 3981(8), dated the 23rd May 2006, for adjudication of the following questions :

“Whether the Contract Labourers deployed through different contractors in smelter plant and captive power plant of NALCO, Angul deserves to fit two pairs of dress/uniform per head per year ? If so, the details ? ”

2. On notices being sent, the workmen did not appear nor filed statement of claim for the reasons best known to them. From this , it can safely be inferred that the workmen have no dispute with the management or they have settled their dispute outside the court in the meantime. Accordingly, an award of no dispute is passed in so far as reference is concerned.
