RESOLUTION

The 17th February 2009

SUBJECT—Restructuring of Cadre of Orissa Agriculture Service

The matter relating to restructuring of the Cadre of Orissa Agriculture Service was under active consideration of Government for some time past.

2. Government, after careful consideration, have been pleased to decide the following :—

- (i) The entry level post of the Cadre of Orissa Agriculture Service shall be in the rank of Class-II (Group-‘B’) carrying the scale of pay of Rs. 6,500—200—Rs. 10,500 subsequently revised to Pay Band-2, Rs. 9,300—34,800 plus Rs. 4,600 as Grade Pay as per the provisions contained in ORSP Rules, 2008.
- (ii) The up-gradation of posts belonging to Class-II (Group-‘B’) and Class-1 (Group-‘A’) in the cadre of Agriculture Service shall be as follows :—

3. This will take effect from the date of issue of the Resolution.

4. Since the entry level post on direct recruitment shall be in the rank of Class-II (Group-'B'), they shall be selected through Orissa Public Service Commission for which the recruitment Rules shall be appropriately amended.
