“Whether the action of the management of M/s Toshali Sands, Puri-Konark Marine Drive Road, Puri in terminating their workman Shri Kishore Chandra Samantasinghar, Gardener with effect from the 28th May 2005 is legal and/or justified ? If not , what relief he is entitled to ? ”

SHORT RECITAL OF THE CASE

The Management, M/s Toshali Sands (ETHNIC Village Resort) has been passing through acute operational and financial hazards for sometime past due to decrease in flow of Tourists causing consequential loss of revenue to the establishment besides investment of huge funds for compliance of statutory requirements, but without expected returns whatsoever. Thereby some grievance and disputes having been raised over the issue, there ensured bipartite talks of setting the matter mutually and amicably. After discussion both parties have agreed to resolve their disputes and differences as per the following :

TERMS AND CONDITIONS OF SETTLEMENT

1. The settlement will be effected from the 24th November 2008.
2. It is agreed by and between the parties that the management shall pay and the workman shall receive the benefits as specifically described in the document (Bank Draft) attached as enclosed here.
3. It has been agreed that the workman shall receive the payment in draft bearing No. 748890, dated the 20th November 2008 for Rs. 31,641 (Rupees Thirty one thousand six hundred forty one only) drawn on Punjab National Bank, Chhaitana, Puri.
4. It is agreed between the parties that by virtue of this settlement all claim and disputes arising out of employment, non-employment and terms of employment of workman stand resolved fully and finally and that no other or further claim or dispute in such respect whatsoever shall lie or be raised by any party in future, as the matter is settled in this I. D. Case No. 61/2006.
5. It is also agreed that the workman shall not pursue any other litigation against the management, relating to this matter and past employment under the management.
6. Both the parties agreed that the above settlement is fair, amicable and reasonable and they have put their respective signatures on their volition and free will without and threat, coercion or undue influence whatsoever.
