NOTIFICATION

The 12th January 2009

S. R. O. No. 23/2009—Whereas in pursuance of the powers conferred by Article 243-ZA of the Constitution of India, Section 62 of the Orissa Municipal Corporation Act, 2003 and Rule 22(1) of Orissa Municipal Corporation (Division of City into Wards, Reservation of Seats and Conduct of Election) Rule, 2003, the State Election Commission has released its poll schedule for the General Election to Cuttack Municipal Corporation to be held on the 6th February 2009 vide Notification bearing No. 72, dated the 7th January 2009;

Whereas, Section 105 of the Orissa Municipal Corporation Act, 2003 empowers the Election Commission to requisition such premises or such vehicle, vessel or animal as the case may be, and such further orders as may appear to him to be necessary or expedient in connection with the requisitioning;

Whereas, a large number of vehicles will be required for transport of member of the police force for maintaining Law and Order during the conduct of such election, or transport of any officer or person for performance of any duties in connection with such election;

Whereas, Section 111 of Orissa Municipal Corporation Act, 2003 authorises the Election Commission to delegate its functions to be exercised or discharged by or such Officer or class of Officers as may be specified therein;

Now, therefore, in exercise of the powers conferred by Section 111 of Orissa Municipal Corporation Act, 2003, the State Election Commission do hereby authorizes the District Magistrate, Cuttack to requisition the vehicles and premises for conduct of General Election to Cuttack Municipal Corporation and Deputy Commissioner of Police, Cuttack to requisition the vehicles required for maintenance of Law and Order during the conduct of General Election.

The hiring charges of the vehicles requisitioned by the District Magistrate, Cuttack and Deputy Commissioner of Police, Cuttack will be borne by the concerned Municipal Corporation as per Section 106(2) of Orissa Municipal Corporation Act, 2003. The cost of P.O.L. for such vehicles will be met out of the allotment placed by the Commission with District Magistrate, Cuttack and Deputy Commissioner of Police, Cuttack separately.
