AWARD

Originally, the Government of Orissa in the Labour & Employment Department had referred the following dispute for adjudication by the Presiding Officer, Labour Court, Bhubaneswar vide its order No. 4809—li/1(B)-286/1991-L.E., dated the 24th July 1992, but subsequently it transferred the dispute to be adjudicated by the Presiding Officer, Industrial Tribunal, Bhubaneswar vide its order No. 4138—li/21-32/2007-L.E., dated the 4th April 2008 :—

“Whether the actions of the management of Bhadrak Co-operative Urban Bank Limited, Bhadrak in dismissing Shri Jagabandhu Das, Ex-Bill Clerk from services vide resolutions, dated the 23rd June 1974 are legal and/or justified ? If not, what relief Shri Das is entitled to ?”

2. In this case, both the parties after filing their respective claim statement and written statement did not appear on the date of hearing. The second party-workman has not tendered any evidence to substantiate his claim, so also the management. In absence of any evidence, therefore it is not possible to answer the reference in any manner. Hence, a No Dispute Award is passed in so far as the present reference is concerned.
