AWARD

The Government of Orissa in the Labour & Employment Department have, in exercise of power conferred upon them under Section 12, read with clause (c) of the sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (for short “the Act”) referred the following dispute for adjudication by the Court.

“Whether the action of the management of employment of M/s National Fire & Security Service, Sambalpur, a Contractor’s Establishment under Baragarh Cement Ltd., Baragarh in refusing employment to Shri Raghunath Mohapatra, Security Guard under the guise of transfer with effect from the 5th November 2004 is legal and/or justified ? If not, to what relief the workman is entitled ?”

2. On notices being sent, the workman did not appear nor filed statement of claim for the reasons best known to him. From this, it can safely be inferred that the workman has no dispute with the management or they have settled their dispute outside the Court in the meantime. Accordingly, an award of no dispute is passed in so far as reference is concerned.
