AWARD

The Government of Orissa in the Labour & Employment Department have, in exercise of powers conferred upon them under Section 12, read with Clause (c) of sub-section(1) of Section 10 of the Industrial Disputes Act, 1947 (for short "the Act") referred the following dispute for adjudication by this Court :—

"Whether the contract labourers of the Contractors of M/s Orissa Poly Fibres Ltd., Godasila, Dhenkanal (Annexure-A) are entitled for 20% bonus for the year 2004-2005 ? If so, what should be the terms of payment ?".

2. On notices being sent, the workmen did not appear nor filed their statement of claim for the reasons best know to them. From this, it can safely be inferred that the workmen have no dispute with the management or they have settled their dispute outside the Court in the meantime. Accordingly, an award of no dispute is passed in so far as reference is concerned.
