AWARD

The Government of Orissa in the Labour & Employment Department in exercise of the power conferred upon them under sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following disputes vide their Memo. No. 5703 (5) L.E., dated the 29th June, 2009 for adjudication of the following disputes :-

“Whether the action of the management of M/s. Regulated Market Committee, At/P.O. Raikia, District Kandhamal in terminating the services of Shri Manoj Kumar Behera, Ex-Watchman with effect from 1-5-2003 is legal/or justified ? If not, what relief Shri Manoj Kumar Behera is entitled to ?”

The workman has not filed his statement of claims along with documents and reliances list of witnesses in spite of direction given by State Government in the reference and also by this court repeatedly. Last time notice was issued to him by Registered Post with A.D. The postal acknowledgement card return back with due service. It is presumed that, there exist no dispute between the parties at present. Hence, I passed a “No Dispute Award” so far as this reference is concerned.
