## AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 7023—li/1(B)-48/2008-LE., dated the 26th June 2008 :—

“ Whether the action of the management of M/s. Raghunath Aluminium, S-2/62, New Industrial Estate, Jagatpur, Cuttack in terminating the employment of Shri Bhagabat Rout, Rolling Mistry with effect from the 22nd October 2007 is legal and/or justified ? If not, to what relief the workman is entitled ?”

2. The workman is absent. No statement of claims is filed. No steps taken to that effect inspite of issuance of Registered notice. In absence of claim statement and evidence on record the case cannot be proceeded further more. Hence, a no Award possible is passed accordingly.
