#### AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 7273—li/1(B)-3/2007-LE., dated the 2nd June 2007 :—

“ Whether the termination of services of Shri Prasant Kumar Mohapatra, Ex-Supervisor (Mechanical) by way of refusal of employment with effect from the 2nd November 2001 by the management of M/s. OSWAL Chemicals & Fertilisers Limited, Paradeep is legal and/or justified ? If not, to what relief Shri Mohapatra is entitled ?”
