## AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 3446-li/1-(B)-2/2006-L.E., dated the 2nd May 2006 :—

“Whether the termination of services of Shri Sikhar Chandra Swain, the workman by the Director, State Resource Centre for Adult Education, Orissa, Bhubaneswar with effect from 1-7-1993 is legal and/or justified ? If not, what relief the workman Shri Swain is entitled to ?”

2. The representative of management is present. The workman is absent. No steps taken. In absence of workman and evidence on record, the reference cannot be answered. Hence, a no Award possible is passed accordingly.
