NOTIFICATION

No. 9904—I-TTI-50/2010-I.—In pursuance of the provisions of the "Orissa Professional Educational Institutions (Regulation of Admission and Fixation of Fee) Act, 2007" and consequent upon the interim order of Hon'ble Supreme Court, dated the 1st June 2007, in SLP (C) No. 10318/2007 and in three others and interim order of the 18th June 2007 in Civil Appeal No.(s) 2872 of 2007, Government of Orissa was pleased to constitute the Policy Planning Body (PPB) vide this Department Notification No.9527, dated the 28th June 2007 under the Chairmanship of Hon' ble Mr. Justice Ch. P. K. Mishra (Retd.). As Hon'ble Mr. Justice Ch. P. K. Mishra (Retd.) tendered his resignation from office of the Chairman, PPB, Hon'ble Chief Justice, Orissa High Court was requested to nominate another Retd. Judge to Chair the PPB. Hon'ble Chief Justice, High Court of Orissa has nominated Shri Justice Arun Kumar Parichha, (Retd.) Judge of High Court of Orissa to Chair the PPB in pursuance / terms of aforesaid order of Hon'ble Apex Court, dated the 18th June 2007.

In view of the nomination made by Hon'ble Chief Justice, High Court of Orissa and in compliance to the aforesaid orders of Hon'ble Apex Court, Government have been pleased to appoint Hon'ble Shri Justice Arun Kumar Parichha, (Retd.) Judge of High Court of Orissa as the Chairman of the PPB constituted vide this Department Notification No.9527, dated the 28th June 2007 with immediate effect. The remuneration pattern / mode of payment of Hon' ble Chairman, PPB is fixed as follows :—

(I) Honorarium	..	Rs. 26,000 per month
(II) Vehicle Charges	..	Rs. 10,000 per month
(III) Sumptuary Allowance	..	Rs. 3,000 per month
(IV) Telephone Charge	..	Rs. 3,000 per month

In addition to above the Chairman of PPB, will be paid an additional amount of Rs. 6,000 towards hiring charge of Steno (4,000 per month) and a Class-IV Employee (Rs.2,000 per month) subject to condition that their will be no restriction to days of sitting of the PPB .
