The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 1204—li/1(B)-66/2004-LE., dated the 3rd February 2005 :—

“ Whether the action of the employer of M/s. Uttarayani Dal Mill, Medical Road, Jatni, Khurda in terminating the services of Shri Upendra Kumar Pattnaik, Supervisor with effect from the 10th February 2002 is legal and/or justified ? If not, to what relief Shri Pattnaik is entitled ?”
