ORDER

The 17th September 2010

No. 3877-SEC.—Whereas, it is reported by the Executive Officer, Karanjia N.A.C. that casual vacancy in the office of Chairperson of Karanjia N.A.C. has occurred due to invalidation of election of Councillorship of Ward No. IX declared by Hon'ble District Judge, Mayurbhanj, Baripada in Election Misc. Case No. 155/2008 on the 26th August 2010;

Whereas, the said incumbent was holding the post of Chairperson of Karanjia N.A.C.;

Whereas, it is necessary to conduct by-election to fill up the said casual vacancy;

Now, therefore, in exercise of powers conferred under Section 49 of The Orissa Municipal Act, 1950 and Rule 68 of The Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994, the State Election Commission appoints following dates for holding of election to fill up the aforesaid casual vacancy.
