The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 8272— li/1(BH) -50/2001-L.E., dated the 23rd August 2003 :—

“Whether the termination of services of Shri Arun Kumar Singh, workman with effect from the 1st July 2000 by the management of M/s Sony Brothers, a Contractors Establishment of M/s Birla Tyres Ltd. is legal and/or justified ? If not, what relief is Shri Singh entitled to ?”
