AWARD

The Government of Orissa in exercise of powers conferred by sub-section (5) of Section 12, read with Clause (C) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947, have referred the matter in dispute to this Court vide Order No. 8121— li/1(BH) -1/2003-L.E., dated the 21st August 2003 of the Labour & Employment Department, Bhubaneswar for adjudication.

2. The terms of reference is as follows :

“Whether the actions of the management of Khairbani Ashram School, Jugpur, Dist. Mayurbhanj leading to termination of services of its workman Shri Saroj Kumar Panda, former Cook-*cum*-Attendant with effect from the 31st May 2001 is legal and/or justified ? If not, what relief Shri Panda is entitled to ?”

3. Parties are absent. No steps taken. The workman though filed his claim statement subsequently remained absent since long even if sufficient opportunities given. In absence of parties and evidence on record a no Award possible is passed accordingly.
