AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 1893—li-1(BH)-36/2000-LE., dated the 13th February 2001 :—

“Whether the action of management of M/s H. S. Rout, a Contractor of M/s Ispat Alloys (P) Ltd., Balgopalpur, Balasore in victimising Shri Gajendra Kar, the Cook in the guise of prolonged suspension with effect from the 15th May 1998 is legal and/or justified ? If not, to what relief he is entitled ?”.

2. The workman is absent. No steps taken. In absence of workman and evidence on record the reference can not be answered. Hence a no Award possible is passed accordingly.
