### AWARD

The Government of Orissa in the Labour and Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 readwith Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 6516—li-1(BH)-5/2001-L.E., dated the 22nd May, 2002 :—

“Whether the action of the management of Basipitha Blacksmithy Panchayat Industry Co-operative Society Limited, Takatput (Baripada), Mayurbhanj in retrenching the workman Shri Akhila Chandra Rana with effect from the 1st June 1998 is legal and/or justified ? If not, to what relief he is entitled ?”

2. Parties are absent and has not taken any steps. In absence of parties and evidence on record, the reference can not be answered. Hence a no Award possible is passed accordingly.
