No. 4561-SEC.—Whereas, the by-election to the office of Sarpanch of Guamal Gram Panchayat under Tihidi Block was communicated vide Commission's Notification No. 3849, dated the 15th September 2010 wherein the date of poll was fixed to the 26th October 2010;

Whereas, the Collector, Bhadrak vide his Letter No. 1202, dated the 11th October 2010 has intimated that the B.D.O.-cum-Election Officer has not followed the date line fixed by the Commission;

Whereas, the State Election Commission, Orissa after considering the report of Collector, Bhadrak has cancelled the schedule of by-election from the stage of scrutiny of nomination vide Order No. 4508, dated the 20th October 2010.
