AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 1337–li/l(B)-2-2005-LE., Dt. 9-2-2006.

“Whether the disengagement of Shri Prasanta Kumar Sahoo, Voucher paid xerox operator by the management of the Text Book Production & Marketing, Bhubaneswar from service with effect from 3-8-2000 is legal and/or justified ?If not, what relief Shri Sahoo is entitled to ?”

2. The workman is absent. No steps taken. On perusal of the case record I found that the workman neither present in the Court nor filed his claim statement till yet. Which amounts that he was not interested to proceed with the case. I also found no reasonable ground to adjourn the case further more as sufficient opportunities given to him. Hence in absence of claim statement and evidence on record a no Award possible is passed accordingly.
