No. 16207—I-TTI-98/2010-I.—It has come to the notice of the Government that some of the promoters of Private Engineering Colleges and Schools are not converting the land under their possession in full from Agricultural purpose to Non-Agricultural purpose under the provisions of Section 8(A) of the OLR Act, 1960. Further it has come to the notice of the Government that the Management of a few Engineering Colleges has encroached Government Land in an illegal manner.

With a view to find out the Trusts/Societies/Organizations who have violated the provisions of Section 8(A) of the OLR Act, 1960 and have encroached Government Land, Government have been pleased to constitute a Committee with following Members to conduct enquiry into the encroachment of Government land by the Management of Private Engineering Colleges and to find out the Trusts/Societies/Organizations who have not converted the Agricultural land under their possession to Gharabari KISSAM.

The aforesaid Committee so constituted will make spot verification of the Technical Institutions such as Engineering Colleges, Engineering Schools/Polytechnics, etc., to verify the land records in all respects i.e. the land records to be scrutinized and examined based on their payment of premium under the provisions of Section 8(A) of the OLR Act, 1960 for full plot towards land conversion ascertain as to whether the Institute campus stands on the converted land (after kism changed to Gharabari) and also to find out if the management of the Institution has encroached any Government Land and to furnish a detailed report within six months to Government. Based upon the report/findings of the Committee, Government will consider for taking action as deemed proper against the erring Institutions who have violated the Rules.
