## A W A R D

The Government of Orissa in the Labour & Employment Department, in exercise of powers conferred upon them by sub-section (5) of Section 12, read with clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No.1201-li/1 (BH)-30/2006-LE., Dt. 7-2-2006 :-

“Whether the refusal of employment of Shri Sridhar Mohanta, work-charged employee by the Executive Engineer, Subarnarekha Field Machinery Division, Laxmiposi, Dist. Mayurbhanj is proper and justified ? If not, to what relief Shri Mohanta is entitled ?”

2. The workman is absent. No steps taken though registered notice issued to him. He has not filed his claim statement till yet though several opportunities given to him. In absence of claim statement and evidence on record No Award is possible.

Hence a No Award possible is passed accordingly.
