No. 5630-SEC.—Whereas, Executive Officer, Deogarh Municipality vide his letter No. 1076, dated the 3rd August 2010 has reported that a casual vacancy in the office of Councillor of Ward No. 06 of Deogarh Municipality has occurred due to declaration of entire election proceeding of Ward No. 6 void by Hon'ble District Judge, Sambalpur in Election petition No. 1 of 2008 on the 13th November 2009;

And whereas, the revision of Electoral Roll of Deogarh Municipality has been completed by the Election Officer concerned;

Now, therefore, the State Election Commission in exercise of powers conferred under Section 45 of Orissa Municipal Act, 1950, read with Rule 77 (2) and Rule 23 (2) of the Orissa Municipal (Delimitation of Wards, Reservation of Seats and Conduct of Election) Rules, 1994 hereby appoints following Schedules, dates and time to conduct by-election to the office of Councillor of Ward No. 06 of Deogarh Municipality :—
