S.R.O. No. 136/2010—Whereas, the Government of Orissa in the Housing & Urban Development Department have, by Notification No. 8675-HUD., dated the 15th April 2010 issued under sub-section (2) of Section 12 of the Orissa Municipal Act, 1950 published in the Official Gazette on the 15th April 2010 called upon all the Wards of Redhakhol N.A.C. to elect their Councillors for the purpose of reconstituting the Municipal Body.
