The P.L.A.C. shall met at least twice a year. The performance and the progress of the P.L.A.C. shall be monitored by the Collector concerned at the District Level, R.D.C. concerned at the Divisional Level and the Director of Industries at the State Level. The General/Project Manager of the District Industries Centre concerned shall be furnish a quarterly progress report to the above monitoring authorities in the format to be prescribed by Director of Industries for the purpose. The Director of Industries in turn shall furnish a comprehensive quarterly report to the Government by 7th day of the beginning of each quarter for the preceding quarter.
