NOTIFICATION

The 3rd June, 2010

S.R.O. No.210/2010—The following draft of certain rules further to amend the Orissa Development Authorities Rules, 1983, which the State Government propose to make in exercise of powers conferred by Section 123 of the Orissa Development Authorities Act, 1982 (14 of 1982) is hereby published as required by Section 125 of the said Act for information of all persons likely to be affected thereby and notice is hereby given that the said draft will be taken into consideration by Government on or after the expiry of a period of fifteen days from the date of publication of this notification in the *Orissa Gazette*.

Any objection or suggestion which may be received from any person in respect of the said draft before expiry of the period so specified above will be considered by the State Government.

DRAFT

1. (1) These rules may be called the Orissa Development Authorities (Amendment) Rules, 2010.

(2) They shall come into force on the date of their publication in the *Orissa Gazette*.

2. In the Orissa Development Authorities Rules, 1983, in rule 6, after sub-rule (3), the following sub-rule shall be inserted, namely :—

“(4) (a) During the period of deputation the concerned employee will draw his grade pay in the existing scale of pay, which is fixed by his/her parent organization.

(b) He/She will be borne in the cadre of parent organization during the period of deputation.

- (c) Pay and allowances will be borne by the borrowing authority under intimation of parent organization.
- (d) The employees will be entitled to Dearness Allowances under the rule of parent organization according to he/she retains the scale of pay under organization.
- (e) HRA allowances will be paid to the deputationist as per norm fixed by the borrowing authority.
- (f) Any loan or advance will be sanctioned by the borrowing authority and the Service Book will be maintained by the borrowing authority.
- (g) He/She shall be entitled to the medical facilities as admissible to him/her as per norm fixed by the borrowing authority.
- (h) The share of CPF/EPF contribution of the employee concerned will be borne by the borrowing authority as per norm fixed by the parent organization and the borrowing authority will deposit the same in the Heads of Accounts of employee concerned. There is no need of change in respect of quantum of EPF contribution from the different Authority.
- (i) The borrowing authority shall liable to pay leave salary in respect of any disability occurred in and even though such disability manifesto after termination from borrowing authority.
 - (i) Borrowing authority may grant leave up to maximum 30 days.
 - (ii) More than 30 days Government full power.
- (j) No joining time is admissible if the employee as its headquarters.
 - (i) Not more than one day excluding holiday is admissible to employee in order to join a new post, when the appointment to such necessity involve a transfer from one station to another.
 - (ii) Unless more than one day shall not be exceeded, except for special reason.
 - (iii) Further, the State Government on such conditions as think fit, may extend the joining time as admissible to any employee.
- (k) When borrowing authority desires, with concurrence of Administrative Department, may revert/repatriate to him/her parent organization before completion of deputation period and vice versa.

- (l) The employee shall not be entitled to any other remuneration and concession of pensionary value unless it is specified on the terms of his/her deputation without specific sanction of parent organization.
- (m) The borrowing authority may initiate disciplinary action against the employee concerned on the ground of misconduct under Orissa Civil Services (Classification Control & Appeal) Rules, 1962 when he violates the rules and regulations of the borrowing authority taking approval of the Administrative Department.
- (n) No deputation shall normally exceed 6 years :
Provided that if it is expedient to do so, the Finance Department of the Government of Orissa shall be consulted".
