AWARD

The Government of Orissa in the labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12 read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No.8287-li/1(B)-34/2003-L.E., dated the 23rd August 2003 :—

“Whether the termination of services of Shri Ajaya Kumar Bhatta loom Fitter, with effect from 4-3-2001 by the Management of M/s. Laxmi Polythene (P) Ltd., New Industrial Estate, Jagatpur is legal and/or justified ? If not what relief is Shri Bhatta entitled to ?”

2. The workman is absent. No steps taken though several opportunities given to him. He has not filed its claim statement till yet. In absence of claim statement and evidence on record no award is possible. Hence a no award possible is passed accordingly.
