“Whether the retrenchment of services of Md. Jabur, Ex-Welder by the way of verbal termination of services with effect from 11-8-2002 by the management of M/s I.T.I. Techno Agro (India), New Industrial Estate, Jagatpur, Cuttack is legal and/or justified ? If not, what relief he is entitled to ?”
