“Whether the action of the management of M/s News Today Pvt. Ltd., Hyderabad in refusing employment to Shri V. Bhaskar Rao, ex-Correspondent, Jeypore with effect from 2nd August 2002 is legal and/or justified? If not, to what relief Shri Rao is entitled?”

2. The workman is absent. No steps taken. In absence of workman and evidence on record the reference cannot be answered. Hence a no Award possible is passed accordingly.
