## A W A R D

This case arises out of the reference made by the Government of Orissa, Labour & Employment Department under sub-section (5) of Section 12, read with Clause (c) of sub-section (1) of Section 10 of the Industrial Dispute Act, 1947 (14 of 1947) in memo No. 683 (5), dated the 2nd February 2010 for adjudication of the scheduled questions :—

“Whether the termination of services of Shri Umakanta Nial, Sakti Suna, Subash Tandi, Chhotalal Yadav, Ganesh Chhotria, Anil Deep, Kiran Tandi and Rohit Nag employed in M/s Rathi Steel & Power Ltd., At Potapali, Sikirdi, P.O. Katapali, Dist. Sambalpur through their Contractor Shri Saroj Kumar Swain by way of refusal of employment with effect from 28-5-2009 is legal and/or justified ? If not, to what relief are these workmen are entitled ?”

2. On notices being sent, the workmen did not appear nor filed statement of claim for the reasons best known to them. From this it can safely be inferred that the workmen have no mind to proceed with the case or they have settled their disputes outside the Court in the meantime. Accordingly, an Award of no dispute is passed in so far as the reference is concerned.
