The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) and Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 9200–li/1-(BH)-13/2005-LE., dated the 29th October 2005 :

“Whether the termination of service of Shri Gadadhar Behera with effect from the 21st October 2002 by the Conservator of Forest and Field Director, Similipal Tiger Reserve, Baripada is legal and/or justified ? If not, to what relief Shri Behera is entitled ?”
