AWARD

The Government of Orissa in the Labour & Employment Department in exercise of powers conferred upon them by sub-section (5) of Section 12, read with Clause (d) of sub-section (1) of Section 10 of the Industrial Disputes Act, 1947 (14 of 1947) have referred the following dispute for adjudication vide their Order No. 7172–li/1(B)-5/2007-LE., dated the 1st June 2007.

“Whether the action of the Executive Engineer, Puri Irrigation Divison, Puri in terminating the services of Shri Judhistira Nayak, N.M.R. Worker with effect from 1st February 2003 is legal and/or justified ? If not, to what relief he is entitled ?”

2. The workman is absent. No steps taken. On perusal of the case record I found that the workman neither present in the Court nor filed his claim statement till yet. Which amounts that he was not interested to proceed with his case. I also found no reasonable ground to adjourn the case further more as sufficient opportunities given to him. Hence, in absence of claim statement and evidence on record a no Award possible is passed accordingly.
