If any Institution will collect any other fee in any name in guise, the same will be seriously viewed and may consider to withdraw NOC and move AICTE for withdrawal of approval in favour of the defaulting institution/College. Government will also impose penalties on the defaulting institution/ College as per the provisions of the Orissa Professional Educational Institutions (Regulation of Admission & Fixation of Fee) Act, 2007, if any institution charges any other amount in any form other than the prescribed Fee Structure.

Any clarification on the Fee Structure, if so necessary, the decision of Government in Industries Department is final and bindings.
