No.I-MFP-1/2008 Mega FP (Vol. II) (pt.), dated the 25th August 2010 and Letter No. 1-MFP-1/2008-Mega FP, dated the 30th May 2011, Ministry of Food Processing Industries, Government of India, New Delhi. Government have been pleased to constitute a District Level Mega Food Park Co-ordination Committee (M.F.P.C.C.) under the Chairmanship of Collector and District Magistrate. As per guideline issued by Ministry of Food Processing Industries, Government of India to promote the Food Processing Sector of District for the success of the scheme which will largely depend upon co-ordination and convergence of various scheme and activities being undertaken by various agencies to ensure the optimal benefit to farmers as well as entrepreneurs and for smooth initiation, implementation and completion of Mega Food Park Projects, Implementing Agency, Union Government, State Government and Local Bodies are required to be synergized and leveraged.
